

competence by <u>Soil and Coast Defence and Land reclamation Service</u> (DG Environment, Soil and Coast Defence);

- Cartography and GIS:

competence by <u>Regional Informative and Information System Service</u> (DG Organisation, Personnel, Information Systems and Telematics), coastal GIS by Geologic, Soils and Seismic Service (DG Environment);

- Maritime transports:

competence by <u>Viability and Internal Navigation</u>, <u>Commercial Port system Service</u> (DG Infrastructural networks, Logistics and Mobility systems)

No, there is not a RER specific budget line dedicated for maritime and coastal affairs, but sector budget for related policies and actions.

### Are you involved in thematic projects (EU MAP)

Yes, we are, with the SHAPE project, concerning ICZM and MSP, collaborating with EU and PAP/RAC.

#### Are you involved in inter-regional or inter-state agreements?

Yes, we are. There is an international agreement concerning the exploitation of resources involving Italy, Croatia and Slovenia. This agreement, originally signed for natural gas wells exploitation, now concerns the exploitation of sand deposits too. The RER has particular interest for sand deposits for beach nourishment purposes.

The Italian Slovenia and Croatia governments signed the Trilateral Agreement for Adriatic Sea protection against marine pollution by ships in northern Adriatic.

#### **Internal Governance and budget**

#### - Do you have a political delegate specially dedicated to ICZM policy?

No, the ICZM policy is shared among different political delegates. The Assessor for Environment, and in particular DG for Environment, Soil and Coast Defense, has a coordinating role.

#### - Do you have an official ICZM policy identified with a publishable document in a website?

Yes, the Guidelines for ICZM, adopted by the Regional Government in 2005 (Deliberation of the Regional Government n. 645 of the 20th January 2005). The Deliberation is published on the following web page

#### - What is your office dedicated to ICZM policy?

There's not a specific office but political and operative boards involving several subjects:

- The ICZM Institutional Committee, formed by 6 Regional Councillorships, 4 Provinces Presidents, 14 Municipalities Mayors);
- The Board of Directors Integrated Project Management (Environment, Soil, Industry, Tourism, Spatial Planning and Agriculture regional Directorates);
- 10 Working Groups (almost 200 experts, scientists and stakeholders).

#### - Do you have a specialized budget for ICZM policy?

No, there is not a RER comprehensive budget dedicated to ICZM policy, but sector budget for related policies and actions.

### Do you have a regular consultation event on ICZM theme or a regular publication for professional or public?

No, there is not a regular publication on ICZM policies, but we have a publication on Emilia-Romagna environmental state every 5 years, and several studies on the Emilia-Romagna coast status.

# - What are the National and regional laws you use for ICZM theme; are they publishable on the website? (English version) or do you have a link on a website?

The Environment Code (D: Lgs. 152/06) brought the rationalization and homogenization of the national laws concerning environment, such as environmental impact assessment, soil defence, water protection against pollution, management of water resources, waste management and reclamations, and compensation regulations against environmental damages.

Law 88/2009 ratifies the acknowledgement of several EC Directives concerning environmental issues ruled by the above mentioned Environment Code.

About **regional laws**: <u>law 20/2000</u> rules the Spatial Planning and the relationship between different levels of governance in the planning process. Regional law <u>9/2002</u> rules the administrative functions concerning the management of State property maritime areas. Regional Law 6/2005 rules the institution of Protected Areas and Natura 2000 sites.

The <u>Deliberation of Regional Government n. 645 of 20<sup>th</sup> January 2005</u> adopted the "Guidelines for the ICZM".

#### Bottom up governance; for ICZM theme

Do you have common tools, formal relations, or data exchange on ICZM thematic with your State?

Yes we do: the **CAMP Italia** project (now the feasibility study phase is undergoing), plans common data banks to be shared between regional and National level.

#### Do you have common tools, formal relations, or data exchange on ICZM thematic with EU?

The Emilia-Romagna Region participates to the assessment that the European Commission is conducting on the implementation of the ICZM Recommendation, collaborating to the writing of the National ICZM Report.

Do you have common tools, formal relations, or data exchange on ICZM thematic with MAP or one of its CAR (PAP/CAR, Plan Bleu...)?

The PAP/RAC of Split city (Croatia) is the promoter of the CAMP Italia project, in which Emilia-Romagna Region participates, and they are our partners for the SHAPE project.

Yes: the Region delegated some competences to the local authorities (Provinces and Municipalities). For example, ICZM Guidelines have been adopted in Spatial (P) and Urban (M) Planning instruments. Moreover the Beach Plans are formulated by the Municipalities.

Not programs, but exchanges are on project base.

Yes, for specific projects we work together with several Universities of our Region (Bologna, Ferrara and Ravenna), with national research centres (CNR-ISMAR) and regional Agencies (such as the regional agency for environmental protection, ARPA).

#### Transnational governance;

Are you involved in thematic networks for ICZM themes (CPMR...EU-MAP, working groups...)?

Yes, for specific projects we work together with several Universities of our Region (Bologna, Ferrara and Ravenna), with national research centres (CNR-ISMAR) and regional Agencies (such as the regional agency for environmental protection, ARPA).

Are you involved in thematic projects (EU, MAP) and how would you describe the sustainability of the network at the end of the projects?

The Emilia-Romagna Region is involved in the Adriatic Euroregion which deals mainly with IZCM themes.

Moreover the Region participates in the following EU projects: SHAPE (IPA Programme), COASTANCE and MAREMED (MedProgramme), MICORE (VII FP), COASTBEST (LIFE+Environment).

#### Are you involved in inter-regional or inter-state agreements for ICZM theme?

Italy signed the ICZM protocol in Madrid (January 2008) but the Government ratification is still pending.

Regional law 3/1999 (artt. 78-83 regulates) the fishing and aquaculture sector and defines a specific Regional Plan in the matter. The Fishery and Aquaculture Regional Plan, approved in 2001 is yearly updated and regulates the subsidy financing management at local level (funds coming from EU, State and Region)

#### - What is your office dedicated to fishing policy,

Since 1975, the Emilia-Romagna Region plans measures for development and enhancement of marine fisheries and aquaculture, promotes scientific research in the field, participates in the preparation of legislation and of national and community interventions.

Tasks of particular importance are:

- local management plans;
- to promote policies of quality control (PCAA mark);
- enhance fish products;
- To manage the territorial sea and maritime domain designed to fisheries and aquaculture;
- identify and manage areas of wildlife protection in the marine environment.

#### - Do you have a specialized budget for fishing policy?

Yes € 1,5 ml for the sport fishing, € 7,1 Ml from the EU FEP and € 2 Ml ca for regional finance: total € 10 Ml ca

To carry out the functions of planning and policy on fisheries and mariculture, the Regional Government is assisted by an advisory committee called the "Blue **Table"** chaired by the Regional Authorities for sea fishing and aquaculture or a his delegate, and composed of: representatives of regional associations of fishermen and vessel owners, representatives of trade associations representing most fish at the regional level, a representative of the Union of Chambers of Commerce, Industry and Agriculture (CCIAA) 'Emilia-Romagna, the heads of the Centers of Cesenatico Marine Research, University of Ferrara and University of Bologna, , the Commanders of the Directorate of Maritime and Coast Guard Ravenna Ravenna and Rimini, and the heads of veterinary services, ports and commerce of the Emilia Romagna, council members responsible for marine fisheries and aquaculture in the provinces of Ferrara, Ravenna, Forlì-Cesena and Rimini and council members with responsibility in the field of marine fisheries and mariculture of the coastal municipalities of Goro, Codigoro, Comacchio, Ravenna, Cervia, Cesenatico, Gatteo, Savignano sul Rubicone, San Mauro Pascoli, Bellaria-Igea Marina, Rimini, Riccione, Misano Adriatico, Cattolica, as well as any other expert as it deems appropriate to consult on specific matters on the agenda.

- Do you have a regular consultation event on fishing theme or a regular publication for professional or public?

Usually the region has regular consultations with the stakeholders on the most important political and administrative decisions.

#### **Bottom up governance for Fishing**

Do you have common tools, formal relations, or data exchange on fishing thematic with your State? The Region participates in the Commissions and Committees established by the Ministry with consultation role and it is also participating in the Monitoring Committee of the European Fisheries Fund.

Do you have common tools, formal relations, or data exchange on fishing thematic with EU?

The Region participates to the initiatives undertaken by the European Community concerning fisheries and aquaculture, in particular through the participation to special programs, and through the preparation of European projects with other Regions and member States for the development of the sector and for fishery sustainability.

Do you have common tools, formal relations, or data exchange on fishing thematic with MAP or one of its RAC?

Relations with the MAP and the RAC are very rare since the participation is a competence of the Ministry and the central government.

The Provinces give contribution to the definition of financing management regulations, remaining the contribution management a direct competence of the Region.

#### Relations with the research organisations

The Emilia-Romagna Region has participated in numerous research projects funded by the European Community with private research centers, universities and public bodies. RER has funded for more than 20 years several applied research projects concerning fisheries and marine aquaculture.

Do you work in any way with private or public research institutions (private companies, universities, etc.) The Emilia-Romagna Region participates in the **Center for Marine Research Foundation**, based in Cesenatico, and it also has numerous relationships with private and university research centers specialized in the issues of fisheries and aquaculture.

**ARPA** (Regional Agency For Environment Protection) manages the regional monitoring system of shores and coastal-marine areas with the **research vessel DAPHNE** moored in Cesenatico harbour.

RER is involved in the **Adriatic Euroregion** which within the ICZM themes deals with fishery and aquaculture issues.

Moreover the Region is involved in the **Adriatic-Inonian Initiative** which deals with fishery and aquaculture issues. The Region has contacts with **GFCM-FAO** (General Fisheries Commission for the Mediterranean) through the Italian Ministry.

The Emilia-Romagna ACC policies in coastal areas are contained in the Guidelines for ICZM (Deliberation CR 645/2005), considering the 9 sectors and in particular sector 1 "Coastal system, risk factors, defence strategies".

# - What is your office dedicated to ACC policy,

The central office, in terms of programme preparation and approval of interventions for coastal defence and adaptation to CC, is the Soil and Coast defence and Land reclamation Service, with the cooperation of decentralised regional offices, Basin Technical Services, for interventions realisation. But adaptation policies are also referred to Urban planning, Infrastructures and Mobility, Industry and Tourism sectors.

# - Do you have a specialized budget for ACC policy? if yes, amount by year?

There is not a pre-defined budget per year for ACC policy, but normally the range for coastal defence interventions programme is about 1,5-2,5 Mil €/year.




- Do you have a political delegate specially dedicated to WFD policy?


In Emilia-Romagna Region Assessor to Environment and to urban requalification is responsible for the WFD policy.

- Do you have an official WFD policy identified with a publishable document in a website? Emilia-Romagna's territory belongs to three different Districts: the Po Valley District, the Northern Appennines District and, for a small portion of mountainous territory, the Central Appennines District. Each River basin management plan contains the official WFD policy for its own territory.

River basin management plans were adopted on February 24<sup>th</sup> 2010.

There is not a specialized budget for the implementation of the WFD concerning the monitoring activities, which are performed by the Regional Agency for the Environment Protection (**ARPA**); as a matter of fact we have specialized budget for the infrastructures realization, and for the action included in the PTA.

There is a specialized budget for infrastructural public works and actions, according to Water Protection Plan

The approval of regional Water Protection plan followed several meeting with public Bodies, Professional Associations and Stakeholders.

Each River basin management plan had both public <u>information and consultation phases</u> (six months to comment in writing on published documents) in order to allow active involvement and consultation, according to article 14 of Directive 2000/60/EC.

- Do you have a regular consultation event on WFD theme or a regular publication for professional or public?

On 2007 Emilia-Romagna Region created a National Forum on water saving and preservation in order increase efficiency in water utilization and improve communication among users, stakeholders and public Bodies involved in water cycle. The link is:
